**HERSHEY’S/ REESE’S LOVERS DOLLAR GENERAL SWEEPSTAKES**

**1. HOW TO ENTER: NO PURCHASE NECESSARY TO PARTICIPATE IN**

**SWEEPSTAKES.** Visit [www.DollarReesesLovers.com](http://www.DollarReesesLovers.com) (the "Website") during the Sweepstakes Period, follow the online instructions to complete the Official Online Entry Form and submit as instructed to register for Sweepstakes. Upon the successful submission of the registration information on the entry form, an entrant will receive one entry into the applicable Entry Period. Entries do not carryover to subsequent Entry Periods. Online entries must be received by no later than 11:59:59 PM ET on the last day of the applicable Entry Period to be eligible to win the prize offered for that Entry Period. Limit one entry per name per e-mail address per day. The Hershey Company's ("Sponsor") computer is the official time keeping device for this Sweepstakes. Proof of e-mailing does not constitute proof of delivery or entry.
